#### SPECIAL PURCHASE

In accordance with Nebraska Statute 23-3109 1a & 3, the Board of Trustees for the Village of Berwyn will be approving the special purchase agreement on December 10, 2024, at 7:00 pm with Kubota to purchase a 2010 Case 95 with loader and grapple. We will be trading in a John Deere 2640 with 46A loader towards that purchase. Because this special purchase agreement is unique, the Board of Trustees for the Village of Berwyn has waived the bidding requirements. This special purchase agreement allows the Village of Berwyn to save a significant amount of money and was authorized on November 27, 2024, by two-thirds vote of the Board of Trustees for the Village of Berwyn. Individuals or entities are invited to provide informal quotes equal to the equipment stated above before December 10, 2024, so that the Board of Trustees for the Village of Berwyn may consider such quotes against the special purchase agreement noted above.
